**TO THE PRESIDENT AND MEMBERS OF THE
COUNCIL OF THE CITY OF PHILADELPHIA:**

I am returning herewith as disapproved Bill No. 070342, passed by City Council on June 14, 2007. This Bill would amend Section 14-1605 by adding a section for Special Regulated uses and adding overflow storage tanks, generally used for sewage, as such a use. The Bill also provides that no special regulated use shall be permitted within 1,500 feet of residentially zoned district (regardless of the actual uses contained therein), specifically, applying to the Sixth and Tenth Councilmanic Districts.

The passage of this legislation will make it difficult for the Water Department to maintain and protect the quality of the environment and provide treatment of the City's sanitary waste. This Bill also restricts the City's ability to comply with federal and state laws that require the proper management of our wastewater system. In short, this legislation restricts the City's ability to protect public health by eliminating a viable and proven technology used by many municipalities. Also, it limits the City's ability to address basement flooding due to intense rain events. Currently, the City has identified two locations where the sanitary system is overwhelmed during severe storm events, which results in sewage overflowing the system and flowing into streams. Through intensive hydraulic analysis, the Water Department has determined that capturing the overflow volume in underground storage tanks and subsequently, pumping the stored volume back into the system for treatment is a safe and effective solution. These storage tanks could be used in flood prone areas where properties get flooded during very intense rainstorms.

I am aware of the community concerns that residents have raised about these storage tanks. Residents believe that their property values will decrease, however, the presence of such a tank will have no more effect on property value than the presence of a sewer. If anything, the absence of the tank can have a dramatic effect on property values where raw sewage is being allowed to discharge. Another community concern is the potential odor of these storage tanks. The tanks are like sewers and are enclosed, completely underground. The contention that these tanks will emit an odor is inconsistent with the experience with tanks in other cities.

The impact on the appearance of the neighborhood is another community concern. The community would be temporarily affected during construction, however, it would look like any other typical construction site. Once the tank is constructed, it will be, essentially, invisible. Any above ground structures related to the storage tanks can be designed so that they are compatible with the other buildings in the near-by community.

These storage tanks would benefit everyone in the adjacent neighborhoods because they will stop raw sewage from overflowing into our rivers and streams. These tanks would not result in any new taxes. However, if the problems go unabated, the City could face very expensive consent decrees and fines that would raise sewer rates for all City residents.

On May 22, 2007, The City Planning Commission at its meeting considered Bill No. 070342 and recommended that it be disapproved because passage of this Bill will endanger the City's efforts to maintain and protect the quality of the environment and provide treatment of the sanitary waste of the City.

Finally, as a matter of good public policy, the City should not implement zoning restrictions based on City Council districts. Either a proposed land use should be banned in all City Council districts, or the restriction should be based on other criteria related to the actual impact of that land use on the community.

For the above reasons, I cannot support Bill 070342.

SECTION 1. Section 19-2902 of The Philadelphia Code is hereby amended to read as follows:

§ 19-2902. Definitions.

As used in this Chapter:

[(1) Dependent. A child who derives more than one-half his or her total support during the entire taxable year from a taxpayer eligible for the special tax provisions of this Chapter. Any person who is a dependent pursuant to the provisions of the Internal Revenue Code during a taxable year shall be deemed a dependent for the purpose of this Chapter.]

[(2)] (1) Homestead. A dwelling used as a home, occupied by a taxpayer as a primary residence. A homestead shall also include mobile homes which are assessed as realty for local property tax purposes and the land upon which the mobile home is situated and other similar living accommodations, as well as a part of a multi-dwelling or multi-purpose building and a part of the land upon which it is built to the extent that the eligible taxpayer is chargeable by the City for property taxes. It shall also include premises occupied by an eligible taxpayer if he or she is required "by law" to pay a property tax by reason of his or her ownership or rental (including a possessory interest) in the dwelling, the land, or both; provided that the term "by law" shall not be deemed to include a contractual obligation between the eligible taxpayer and a person who would otherwise be responsible to the City for the amount of the tax. An owner includes a person in possession under contract of sale, deed of trust, life estate, joint tenancy or tenancy in common.

[(3) Income. All income from whatever source derived, including but not limited to salaries, wages, bonuses, commissions, income from self-employment, alimony, support money, cash public assistance and relief, the net amount of any pensions or annuities including railroad retirement benefits, all benefits received under the Federal Social Security Act (except

Medicare benefits), all benefits received under State employment insurance laws and veterans' disability payments, all interest received from the Federal or any State government, or any instrumentality or political subdivision thereof, realized capital gains, net incomes from rentals, workmen's compensation and the gross amount of loss of time insurance benefits, life insurance benefits and proceeds (except the first ten thousand dollars (\$10,000) of the total of death benefit payment), and gifts of cash or property (other than transfers by gift between members of a household) in excess of a total value of five hundred dollars (\$500), but shall not include surplus food or other relief in kind supplied by a governmental agency or property tax rebate.]

[(4)] (2) Low income taxpayer.

(a) For tax year 2008 and all prior tax years, a [A] taxpayer whose income does not exceed the "maximum annual income" allowable for an "eligible claimant" to participate in the Commonwealth's program for Pharmaceutical Assistance for the Elderly ("PACE") pursuant to the Lottery Fund Preservation Act, 72 P.S. § 3762-101 et seq.

(b) For tax year 2009 and thereafter, a taxpayer whose income does not exceed the maximum annual income allowable for an eligible claimant to participate in either the Pharmaceutical Assistance Contract for the Elderly (PACE) program or the Pharmaceutical Assistance Contract for the Elderly Needs Enhancement Tier (PACENET) established under Chapter 5 of the State Lottery Law, 72 P.S. §3761-501 et seq.

(c) For purposes of this Section, "income" shall be defined as it is in Chapter 5 of the State Lottery Law.

[(5)] Poverty. An economic condition wherein the total amount of household income is insufficient to adequately provide the taxpayer, his spouse and dependent children with the necessities of life. For the purpose of determining eligibility for the tax exemptions and special tax provisions of this Chapter, a taxpayer is deemed to be living at a poverty level if the taxpayer meets the low income provisions herein defined.]

[(6)] (3) Real estate taxes. All taxes on a homestead imposed or authorized to be imposed pursuant to §19-1301 and §19-1801.

[(7)] (4) Senior citizen. A taxpayer who is sixty-five years of age or over, or whose spouse, if a member of the household, is sixty-five years of age or

The Fairmount Park Commission shall consist of ~~the commissioners of Fairmount Park and shall be constituted in accordance with the provisions of the Act of March 26, 1867, P.L. 547, as amended~~ *the Recreation Commissioner, the Water Commissioner, and thirteen members appointed to four year terms by the Mayor, with the advice and consent of a majority of all the members of the Council, from among the persons whose names are submitted to the Mayor by the Fairmount Park Commission Panel.* ~~The Recreation Commissioner shall be a member of the Commission, ex officio.~~ *The persons whose names are submitted to the Mayor by the Fairmount Park Commission Panel shall each have a demonstrated interest in and knowledge of the City's parks and possess skills that address the needs of a large park system, including, but not limited to, expertise in natural lands management, watershed management, and environmental protection; land use and urban planning; recreation; tourism; marketing and public relations; business and finance; economic development; neighborhood and community revitalization; historical and architectural preservation and maintenance; landscaping and horticulture; planning and fundraising; and public/private partnerships. Such persons shall also reflect the geographic, racial, income and gender diversity of the residents of the City.*

In addition to the powers and duties previously vested in the Fairmount Park Commission by statute or ordinance, it shall be among the Fairmount Park Commission's duties to: (a) expand and diversify funding and resources for operations and capital improvements, including generating more revenue from Fairmount Park property; (b) prepare recommendations for the legislative and executive branches regarding priorities for operating and capital expenditures in Fairmount Park as deemed necessary by the Fairmount Park Commission; (c) draft, promulgate, approve, and amend as necessary, policies and standards for the acquisition, deacquisition, lease, sale, development or other use of land located in Fairmount Park, provided such policies and standards shall not be binding on the Council; (d) draft and issue to the public an annual "State of the Parks" report, detailing annual income, expenses, and an inventory of capital assets, as well as an update on ongoing projects; (e) when a vacancy exists or is anticipated, conduct a search for and recommend a candidate to the position of Fairmount Park Director although final authority for appointment of the Fairmount Park Director shall rest with the Mayor of Philadelphia; and (f) perform all actions in conformance with the rules and regulations promulgated by the Board of Ethics.

(1) The amendment to Section 3-905 providing for the appointment of the members of the Fairmount Park Commission by the Mayor, with the advice and consent of Council, shall take effect January 31, 2008.
