Public Hearing Notice

The **Committee on Streets and Services** of the Council of the City of Philadelphia will hold a Public Hearing on **Monday, December 3, 2018**, at **10:00 AM**, in **Room 400, City Hall**, to hear testimony on the following items:

- 170517** An Ordinance amending Section 9-605 of The Philadelphia Code, entitled 'Towing,' by increasing the amount of the fine that a towing company must pay for improper clean-up of an accident scene; all under certain terms and conditions.
- 180742** An Ordinance establishing no truck parking and tow-away regulations on Commerce Way from McNulty Road to its terminus further northeastwardly therefrom.
- 180822** An Ordinance amending Chapter 12-1300 of The Philadelphia Code, entitled "Enforcement and Obedience to Traffic Regulations," by increasing the associated penalty for violating this Chapter.
- 180865** An Ordinance establishing a one-way regulation on Aspen Street, from North Markoe Street to North 46th Street, eastbound.
- 180910** An Ordinance establishing no truck parking and tow-away regulations on both sides of Darnell Road from Decatur Road to Dutton Road.
- 180941** An Ordinance establishing parking regulations in the vicinity of: 45th street and Spruce street; Cedar avenue and 47th street; 34th street and Brandywine street; Farragut street and Walnut street.
- 180942** An Ordinance establishing parking regulations in the vicinity of: Larchwood avenue and S. 47th street; Larchwood avenue and S. 59th street; N. 33rd street and Spring Garden street; Delancey street and S. 51st street; Sansom street and S. 51st street; S. 61st street and Chestnut street.
- 180995** An Ordinance establishing parking regulations in the vicinity of: Brandywine street and N. 33rd street; Larchwood street and S. 45th street; S. 44th street and Spruce street; Cedar avenue and S. 54th street; Sloan street and Baring street; Belmont avenue to Girard avenue; Hamilton street to N. 38th street.
- 181010** An Ordinance authorizing the revision of lines and grades on a portion of City Plan Nos. 12-S and 19-S by relocating the northeasterly houseline and curbline of Tasker Street, from Christopher Columbus Boulevard to a point southeastwardly therefrom, relocating the southeasterly curbline of said Christopher Columbus Boulevard from Tasker Street to Reed Street varying distances northwestwardly, and relocating a portion of the southwesterly curbline of Dickinson Street, from said Christopher Columbus Boulevard to a point northwesterly therefrom, a uniform distance northeastwardly, all under certain terms and conditions,
