#### AN ORDINANCE

Establishing parking regulations in the vicinity of Jackson street between S. 12th street and S. 13th Street; Snyder avenue between S. 13<sup>th</sup> street and Juniper street; Jackson street between S. 6<sup>th</sup> street and S. 7<sup>th</sup> street; Mercy street between S. 7<sup>th</sup> street and S. 8<sup>th</sup> street; Watkins street between S. 11<sup>th</sup> street and S. 11<sup>th</sup> street; S 7<sup>th</sup> street between Johnston street and Oregon Ave; Moyamensing avenue between S. 5<sup>th</sup> street and S. 6<sup>th</sup> street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The following parking regulation is hereby established. Two Hour Parking 7:00 AM – 8:00PM Monday – Friday Except RPP# 24 Jackson street, both sides, S. 12th street to S. 13th street

SECTION 2. The following parking regulation is hereby established. Two Hour Parking 8:00 AM – 8:00 PM Monday – Sunday Except RPP# 24 Snyder avenue, north side, S. 13th street to Juniper street

SECTION 3. The following parking regulation is hereby established. Two Hour Parking 2:00 PM– 10:00 PM Monday – Sunday Except RPP# 24/34 Jackson street, both sides, S. 6th street to S. 7th street

SECTION 4. The following parking regulation is hereby established. Two Hour Parking 8:00 AM- 10:00 PM Monday - Sunday Except RPP# 24 Mercy street, north side, S. 7th street to S. 8th street
