WHEREAS, Brenda Kaye Brabham, serves as a positive role for all young people, graduating from Dobbins High School in June of 1999 and attending LaSalle University where she was a member of the National Honor Society, National League of College Scholars, achieved outstanding grades and was placed on the Dean's List from the years 2000 through 2003; and

WHEREAS, Brenda Kaye Brabham graduated from LaSalle University Cum Laude in January 2004; and continues as a positive role model for young people as an active volunteer in the after school program Gear Up, serves as a mentor to young people, volunteers as a group leader in the Boys and Girls Clubs of Philadelphia and volunteers as a Life Skills Instructor to young women; and

WHEREAS, Brenda Kaye Brabham has as her career ambition, a desire to help others such as battered women and foster children to achieve whatever their desires may be in life and that her positive character traits and ambitions were recognized by the pageant judges; now therefore
