BILLS AND RESOLUTIONS ON FINAL PASSAGE

Resolution No. 180400: Resolution Authorizing the Philadelphia Land Bank to dispose of 1728 Marlton Avenue located in the Third Councilmanic District in accordance with the terms of Chapter 16-700 of The Philadelphia Code.

THE RESOLUTION WAS ADOPTED.

Resolution No. 180401: Resolution Calling on the United States Congress to release the necessary funding required to dredge the Schuylkill River, which is crucial in maintaining Philadelphia's status as the nation's best competitive rowing city.

THE RESOLUTION WAS ADOPTED.

Resolution No. 180404: Resolution Calling on Congress to reject the proposal from HUD Secretary Ben Carson, which would triple the minimum rent cost for
