WHEREAS, Coach Robert "Dondi" DeShields led his team to a 97-83 victory over Potomac State College of West Virginia with the help from Rashaad Slappy and Tyrone Hill who had a combined 54 points and Hill dominated the boards with 26 hard fought rebounds; and
