## RESOLUTION

Recognizing Halloween, the Greater Philadelphia Tourism Marketing Corporation (GPTMC), a company that knows how to promote all-things fun in Philly, and its partners.

WHEREAS, Elvira will also visit Philadelphia’s iconic Halloween attractions, including the historic Eastern State Penitentiary for Terror Behind the Walls and the Park Hyatt Philadelphia at the Bellevue for a Halloween party in the very hotel where Bram Stoker penned portions of the classic novel “Dracula;” and

WHEREAS, Philadelphia is home to some of the nation’s most historic and authentic buildings such as Eastern State Penitentiary, with a storied past that is the real deal; and
