The **Committee of the Whole** of the Council of the City of Philadelphia held a Public Hearing on **Friday, June 10, 2011**, and recessed the public hearing until **Thursday, June 16, 2011 at 9:00 AM**, in **Room 400, City Hall**, to hear further testimony on the following:

- 110135** An Ordinance to adopt a Capital Program for the six Fiscal Years 2012-2017 inclusive.

- 110136** An Ordinance to adopt a Fiscal 2012 Capital Budget.

- 110137** An Ordinance adopting the Operating Budget for Fiscal Year 2012.

- 110138** An Ordinance amending Chapter 19-1500 of The Philadelphia Code, entitled "Wage and Net Profits Tax," by revising certain tax rates and making technical changes, all under certain terms and conditions.
