
AN ORDINANCE

To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Roosevelt Boulevard, 9th Street, Erie Avenue, and Broad Street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Roosevelt Boulevard, 9th Street, Erie Avenue, and Broad Street from the existing zoning designations indicated on Maps "A1," "A2," "A3," "A4," "A5," "A6," and "A7," set forth below, to the zoning designations indicated on Maps "B1," "B2," "B3," "B4," "B5," "B6," and "B7," set forth below.


SECTION 2. This Ordinance shall become effective immediately.













Map A4 Existing Zoning



Map B4 Proposed Zoning









Map A6 Existing Zoning



Map B6 Proposed Zoning




