- 130124** An Ordinance amending Chapter 12-3000 of The Philadelphia Code, entitled "Use Of An Automated Red Light Enforcement System To Prevent Red Light Violations," by authorizing the installation of a red light enforcement system at the intersection of Stenton Avenue and Ogontz Avenue, all under certain terms and conditions.
- 130300** An Ordinance authorizing Beacon on E. Girard Inc. dba Kraftwork to construct, own and maintain an open-air sidewalk café at 541 E. Girard Avenue, Philadelphia, PA, under certain terms and conditions.
- 130301** An Ordinance regulating the direction of movement of traffic on Warnock Street between Montgomery Avenue and Berks Street.
- 130302** An Ordinance establishing a no parking regulation on North Warnock Street,

- 130303** An Ordinance authorizing the revision of lines and grades on a portion of City Plan No. 55 by striking from the City Plan and vacating the legally open portions of Adams Avenue from Aramingo Avenue to its terminus southeastwardly therefrom, striking from the City Plan and vacating Church Street from Aramingo Avenue to its terminus southeastwardly therefrom, and reserving and placing on the City Plan rights-of-way for drainage purposes within the lines of a portion of Aramingo Avenue being stricken and within the lines of Church Street being stricken, all under certain terms and conditions.
- 130304** An Ordinance establishing a no truck parking regulation on Godfrey avenue, from Tabor road to Whitaker avenue, both sides.

- 130353** An Ordinance authorizing the revision of lines and grades on a portion of City Plan No. 319 by striking from the City Plan and vacating the legally open portion of Pennway Street from Rhawn Street to a point approximately five-hundred fifty feet southwestwardly therefrom, under certain terms and conditions.
- 130354** An Ordinance authorizing the revision of lines and grades on a portion of City Plan No. 307 by striking from the City Plan and vacating Water Street from Race Street to its terminus southwardly therefrom and placing on the City Plan a right-of-way for various utility purposes such as may be necessary within the lines of the said Water Street being stricken, under certain terms and conditions.
- 130355** An Ordinance authorizing the plotting upon a portion of City Plan No. 58 of a two feet wide area for public pedestrian use extending along the southerly side of Pearl Street, from Tenth Street to a point approximately one-hundred thirty-eight feet westwardly therefrom, and the relocation of the curblines of Pearl Street, from Tenth Street to a point approximately one-hundred thirty-eight feet westwardly therefrom, so as to widen the cartway of said Pearl Street, and authorizing the acceptance of the grant to the City of the said area for public

- 130357** An Ordinance authorizing Jerry's Bar to construct, own and maintain an open-air sidewalk café at 129 W. Laurel Street, Philadelphia, PA, under certain terms and conditions.
- 130358** An Ordinance establishing a one-way regulation on East Price Street from Sprague Street to Boyer Street, westbound.
