AN ORDINANCE

Establishing parking regulations in the vicinity of: Lawrence street and Somerville avenue; Ashdale street and N. 2nd street; Fairhill street and Tabor road; Chew avenue and N. 5th street; Howard street and Fisher avenue; Tabor road and N. 5th street; Elkins street and N. 7th street; Somerville avenue and N. 4th street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The following parking regulation is hereby established:

One Hour Parking
8:00 AM – 11:00 PM
Monday – Sunday
Except RPP# 18

Lawrence street, both sides, Somerville avenue Tabor road

SECTION 2. The following parking regulation is hereby established:

Two Hour Parking
8:30 AM – 9:30 PM
Monday – Sunday
Except RPP# 18

Ashdale street, both sides, N. 2nd street to N. 3rd street.

SECTION 3. The following parking regulation is hereby established:

Two Hour Parking
8:00 AM – 8:00 PM
Monday – Saturday
Except RPP# 18

Fairhill street, both sides, Tabor road to Somerville avenue.
