WHEREAS, Kalaya began as a modest 32-seat BYOB in South Philadelphia named in honor of Chef Chutatip Nok Suntaranon's beloved mother. Through Chef Nok's vision, passion, and dedication, the restaurant quickly garnered widespread recognition, leading to its relocation to a larger space in Fishtown; and
