AN ORDINANCE

Amending Section 12-918 of The Philadelphia Code, entitled "Parking for Car Sharing Organizations," by adding locations, all under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 12-918 of The Philadelphia Code is hereby amended as follows:

§12-918. Parking for Car Sharing Organizations.

* * *

- (3) One **or more** parking spaces may be reserved for vehicles owned by car sharing organizations on each of following blockfaces, at specific locations to be designated by the Philadelphia Parking Authority:
 - a) On Baltimore Ave between 49th & 50th Streets, north side (1 space)
 - b) On Sansom Street between 35th & 36th Streets, north side (1 space)
 - c) On 40th Street between Locust & Walnut Streets, east side (1 space)
 - d) On 40th Street between Spruce & Locust Streets, east side (1 space)
 - e) On Baring Street between 35th & 36th Streets, south side (1 space)
 - f) On Pine Street between 46th & 47th Street, north side (1 space)
 - g) On 18th Street between Fitzwater & Catherine Streets, east side (1 space)
 - h) On 34th Street between Cuthbert & Arch Streets, east side (1 space)
 - i) On Pine Street between 44th & 45th Streets, north side (1 space)
 - i) On Lombard Street between 18th & 19th Streets, south side (1 space)
 - k) On Fitzwater Street between 21st & 22nd Streets, north side (1 space)
 - 1) On 21st Street between Walnut & Chancellor Streets, east side (1 space)
