## AN ORDINANCE

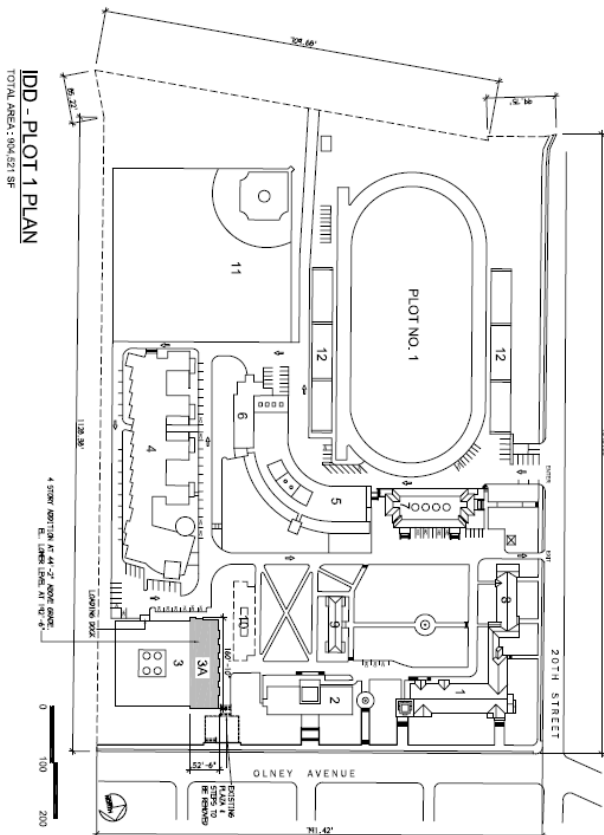
To amend the Institutional Development District Master Plan of LaSalle University by allowing for the expansion of Holroyd Hall.

### *THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Pursuant to Section 14-1107(c) of The Philadelphia Code, The Institutional Development District Master Plan of LaSalle University is hereby amended by allowing for the expansion of Holroyd Hall as set forth in Exhibit "A", on file with the Chief Clerk's Office.

SECTION 2. This Ordinance shall take effect immediately.
