WHEREAS, By 1914, the membership had grown to over 500 and the main purpose of the organization was to welcome ships departing from Ireland and traveling to Philadelphia. The Men of Mayo would greet the young travelers who didn't have any family or friends to introduce them to the ways of their new world; and

WHEREAS, In 1964, women were admitted into the Association which changed its name to the Mayo Association of Philadelphia. In 1981, Attracta O'Malley became the first female president of the Association; and

WHEREAS, The Association is comprised of immigrants and descendants of emigrants from the wonderful County of Mayo; and

WHEREAS, The Mayo Association has helped numerous people and causes throughout its existence including donations to aid in the construction of the shrine in Knock, County Mayo and raising over \$60,000.00 for the Western Care Organization in Castlebar, Aras Attracta in Swinford, County Mayo and St. John of God in Westville, New Jersey. These organizations help mentally and physically challenged children; and

WHEREAS, The men and women of Mayo have also supported disadvantaged around the world including the Kosovo Relief Fund and the famine relief fund in Somalia. Locally, the Association donated \$10,000.00 to "The Irish Memorial" at Penn's Landing, dedicated to the memory of the over one million Irish who perished during the years 1845-1850; now therefore

ARTICLE V
EXECUTIVE AND ADMINISTRATIVE BRANCH POWERS AND DUTIES

Managing Director and Departments, Boards and Commissions under his Supervision

CHAPTER 4
FIRE DEPARTMENT

§5-400. Functions.

The Fire Department shall have the power and its duty shall be to perform the following functions:

* * *

(f) The Department shall carry out its powers and duties, and the Fire Commissioner, Managing Director and the Mayor shall manage and supervise the Department, in accordance with any standards adopted by Council by ordinance under Section 5-401.

§5-401. Fire Code.

Within one year after the effective date of this charter, the Fire Department shall prepare, with the aid of the Law Department, and submit to the Council for its consideration a comprehensive Fire Code which shall embrace all matters to which the powers and duties of the Fire Department extend and which shall have as its purpose the prevention of fires and explosions and the protection of the people of the City and their property from the danger thereof. Council shall also have the power to adopt by ordinance standards for the organization of the Fire

Department and the manner by which the Fire Department carries out its powers and duties, including the deployment of Fire Department personnel in fire suppression operations, emergency medical operations, and special operations. In exercising such power, Council may adopt by reference, in whole or in part, and with such changes as Council deems appropriate, any applicable national standards, such as the National Fire Protection Association's NFPA 1710, "Standard for the Organization and Deployment of Fire Suppression Operations, Emergency Medical Operations, and Special Operations to the Public by Career Fire Departments."

WHEREAS, The Redevelopment Authority of the City of Philadelphia (hereinafter "Redevelopment Authority") has prepared and submitted an urban renewal plan and a redevelopment proposal for the redevelopment of the New Kensington - Fishtown Urban Renewal Area, (hereinafter "New Kensington - Fishtown"), which said plan and proposal were approved by Ordinance of the Council on June 13, 1997, as amended; and

WHEREAS, The Redevelopment Authority has prepared a redevelopment contract for a portion of the New Kensington - Fishtown, designated as Parcel No. 69 also sometimes identified by respective house number and street address as 1530 East Palmer street (hereinafter "Parcel"). The area of said Parcel is bounded as follows:

Parcel No. 69 (1530 East Palmer street).

All that certain lot or piece of ground located in the Eighteenth Ward of the City of Philadelphia situated on the southwesterly side of East Palmer street at the distance of sixty feet southeastward from the southeasterly side of Sepviva street; Containing in front or breadth on Palmer street twenty feet and extending of that width in length or depth southwestward between parallel lines at right angles to

Palmer street a distance of eighty eight feet.

The said redevelopment contract is in substantial conformity with the amended urban renewal plan and the amended redevelopment proposal approved by the Council.

WHEREAS, Theresa Alicea desires to enter into the said redevelopment contract for the Parcel; and

WHEREAS, The Redevelopment Authority has prepared a disposition supplement providing, inter alia, for development controls and regulations imposed upon the Redeveloper.

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That the redevelopment contract submitted by the Redevelopment Authority of the City of Philadelphia (hereinafter "Redevelopment Authority") for the redevelopment of that portion of the New Kensington - Fishtown Urban Renewal Area, as hereinabove more particularly described, is hereby approved. City Council authorizes the Redevelopment Authority to proceed with minor changes in substantial conformity with the hereby approved redevelopment contract. The Redevelopment Authority is authorized to execute the hereby approved redevelopment contract with Theresa Alicea (hereinafter "Redeveloper"). The Redevelopment Authority and the Redeveloper are authorized to take such action in substantial conformity to the redevelopment contract as may be necessary to carry it out.

RESOLVED, The Redevelopment Authority and the Redeveloper are authorized to prepare or cause to be prepared for introduction into the Council such ordinances or resolutions as may be necessary for changes in zoning, streets, alleys, public ways, street patterns, location and relocation of public utilities, and related items which are required in order to facilitate and effectuate the redevelopment contract and disposition supplement hereby approved. Accordingly, the Council hereby declares that it will cooperate in helping to carry out the redevelopment contract and requests the various officials, departments, boards and agencies of the City having administrative responsibilities in the premises likewise to cooperate to such end and to exercise their respective functions and powers in a manner consistent with the redevelopment contract.
