RESOLUTION

Honoring and recognizing Reverend Donald D. WHEREAS, Reverend Moore is married to Dr. Pamela Moore with two sons, Aubrey, a recent graduate of Temple University and Daundre, a junior at North Carolina A&T State University; and

WHEREAS, The West Philadelphia community and members of Mount Carmel Baptist Church excitedly welcome Reverend Moore as man of God who has a strong and
