- 110846 An Ordinance amending Title 9 of The Philadelphia Code, entitled "Regulation of Businesses, Trades and Professions," and Title 14 of The Philadelphia Code, Planning," by adding entitled "Zoning and special provisions regulating advertising signs in designated Commercial Advertising Districts; designating the area bounded by 13th Street, Arch Street, 12th Street, and Filbert Street as a Commercial Advertising District, all under certain terms and conditions.
- 110847 An Ordinance to amend the Institutional Development District Master Plan of the Aria Health System - Torresdale Campus (formerly Frankford Hospital), located at 10800 Knights Road, by allowing for the construction of a building addition to be used for emergency and outpatient services.
