AN ORDINANCE

Amending Section 9-204 of The Philadelphia Code, entitled “Sidewalk Vendors in Center City,” by eliminating previously designated vendor locations in Center City; and by revising and adding to the list of locations that shall not be designated for vending; all under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-204 of The Philadelphia Code is hereby amended to read as follows:

§9-204. Sidewalk Vendors in Center City.

* * *

(8) Vending Locations.

(a) The following vendor locations are hereby designated as locations from which vending shall be permitted, provided Council shall not ever designate more than 300 such locations in all of Center City:

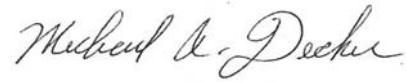
