## RESOLUTION

Authorizing the Council President to appoint certain individuals to serve as the Council President's representative on various boards and commissions.

WHEREAS, Paragraph II(13) of the Rules of Council provides that the Council President may, with the approval of Council by resolution, appoint a representative to act in the President's stead at any meetings of any City board, commission or advisory committee of which the President is an ex-officio member and at any meetings of the Board of Directors of a quasi-public agency or public authority of which the President is an ex-officio member; now, therefore,
