WHEREAS, Chef Ariq Barrett was inspired to launch Kidz Meals on Wheels after seeing children in Philadelphia who were in need of food during the start of the COVID-19 pandemic and decided to create the organization in March 2020; and

WHEREAS, With the help of Laura Lacy, who provided a space that served as the organization's location for preparing and delivering meals, Ariq Barrett was able to deliver over 12,000 boxed lunches; and

WHEREAS, In 2015, Barrett founded Black Kidz Can Cook which is a summer program that focuses on teaching kids the importance of good nutrition, cooking healthy meals, and using their culinary skills to give back to their community; and

WHEREAS, Since the launch of Black Kidz Can Cook, which started with just 10 kids, Barrett has passed on his culinary skills to over 300 kids; and

WHEREAS, Barrett's love for both his community and cooking is what inspired him to persevere through personal obstacles and use his culinary skills as a way to help others, which is why he thinks it is very important to pass this skill on to the next generation; now, therefore, be it
