WHEREAS, The Rosenblatt Family CVI Center's mission includes providing comprehensive clinical evaluations, individualized educational strategies, family support programming, and advancing research to better understand and treat CVI; and

WHEREAS, Overbrook School for the Blind, a Philadelphia institution with over 190 years of service, continues to be a national leader in educating and empowering students who are blind or visually impaired, and the new CVI Center builds upon this legacy; now, therefore, be it
