An Ordinance amending Chapter 10-800 of The Philadelphia Code, entitled "Safety," by adding a new Section, entitled "Acquisition or Transfer of Firearms," to regulate the acquiring or transferring of any firearm within the City of Philadelphia; all under certain terms and conditions.

An Ordinance amending Chapter 9-200 of The Philadelphia Code, entitled "Commercial Activities on Streets," by amending Section 9-211, entitled "Boxes for the Distribution of News and Printed Material," relating to the regulation of newspaper boxes on the public sidewalk, by prohibiting the placement of a publishers' box within the vicinity of the National Museum for Jewish American History, all under certain terms and conditions.

An Ordinance amending Section 9-205 of The Philadelphia Code, entitled "Sidewalk Sales," to prohibit vending on both sides of Aramingo Avenue and within a one block radius on all streets intersecting Aramingo Avenue, between Lehigh Avenue and Duncan Street; all under certain terms and conditions.
