RECORD DESCRIPTION

ALL THAT CERTAIN tract or parcel of ground.

SITUATE in the 40th Ward of the City of Philadelphia, bounded and described in accordance with a plan made by Albright and Friel Inc., Consulting Engineers of Philadelphia, Pennsylvania, dated May 1, 1962 as follows:
