Public Hearing Notice

The **Committee on Streets and Services** of the Council of the City of Philadelphia will hold a Public Hearing on **Tuesday, November 14, 2017, at 1:00 PM**, in **Room 400, City Hall**, to hear testimony on the following items:

- 170363** An Ordinance establishing a no truck parking regulation on the 1900 block of North 76th Street between Overbrook Avenue and City Avenue, both sides.
- 170713** An Ordinance authorizing 2601 Pennsylvania Avenue Condo Association, ("Owner") to install, own and maintain a sign encroachment at 2601 Pennsylvania Avenue, Philadelphia, PA 19130 ("Property"), under certain terms and conditions.
- 170723** An Ordinance authorizing Germantown Special Services District, ("Owner") to install, own and maintain various bollard encroachments at 57 W. Maplewood Mall, Philadelphia, PA 19144 ("Property"), under certain terms and conditions.
- 170820** An Ordinance to amend Title 11 of The Philadelphia Code, entitled "Streets," by revising certain provisions of Chapter 11-600, entitled "Construction, Encroachments, and Projections Over, On, and Under Streets," to amend the encroachment regulations for signage, all under certain terms and conditions.
- 170823** An Ordinance authorizing the relocation of the southerly curblineline of Carpenter Street, from Broad Street to Fifteenth Street on City Plan No. 15-S, a variable distance southwardly, so as to widen the cartway of said Carpenter Street, authorizing the plotting on said City Plan of an area for public pedestrian use extending along the southerly side of Carpenter Street, from Broad Street to Fifteenth Street, and authorizing acceptance of the grant to the City of the said area for public pedestrian use, under certain terms and conditions.
- 170824** An Ordinance authorizing the revision of lines and grades on a portion of City Plan No. 359 by relocating the southwesterly houseline and curblineline of Byberry Road, from The Roosevelt Boulevard to a point northwestwardly therefrom, and plotting on the City Plan a right-of-way for sewer and drainage purposes, contiguous with the northwesterly side of The Roosevelt Boulevard and extending from Byberry Road southwestwardly to a right-of-way for drainage purposes, all under certain terms and conditions, including the dedication to the City of the bed of the widened portion of Byberry Road being placed on the City Plan.
- 170825** An Ordinance amending Section 2 of an Ordinance (Bill No. 130355) approved June 17, 2013, entitled "An Ordinance authorizing the plotting upon a portion of City Plan No. 58 of a two feet wide area for public pedestrian use extending along the southerly side of Pearl Street, from Tenth Street to a point approximately one-hundred thirty-eight feet westwardly therefrom, and the relocation of the curblines of Pearl Street, from Tenth Street to a point approximately one-hundred thirty-eight feet westwardly therefrom, so as to widen the cartway of said Pearl

Street, and authorizing the acceptance of the grant to the City of the said area for public pedestrian use, all under certain terms and conditions," by extending the period for compliance with the terms and conditions stated therein.

- 170826** An Ordinance revising parking restrictions on Maplewood Avenue, between Greene Street and Wayne Avenue.
- 170850** An Ordinance authorizing Ralston Center, ("Owner") to install, own and maintain bench encroachments on Spring Garden Street, Brown Street, N. 37th Street, N. 35th Street, and N. 34th Street, Philadelphia, PA 19104 ("Property"), under certain terms and conditions.
- 170851** An Ordinance authorizing and directing the changing of the name of Convention Avenue, from Health Sciences Drive to South Street, to Health Sciences Drive, under certain terms and conditions.
- 170855** An Ordinance authorizing Passyunk Avenue Revitalization Corporation, ("Owner") to install, own and maintain various planter and bike rack encroachments on Passyunk Avenue, S. 12th Street, Morris Street and Watkins Street, Philadelphia, PA 19147 ("Property"), under certain terms and conditions.
- 170895** An Ordinance establishing parking regulations on: the 4700 block of Locust Street; the 4700 block of Spruce Street; and the 200 block of S. 47th Street.
- 170896** An Ordinance establishing parking regulations on: the 300 block of N. 36th Street; the 300 block of N. 35th Street; and the 3500 block of Powelton Avenue.
- 170905** An Ordinance amending Section 9-203 of The Philadelphia Code, entitled "Street Vendors," by prohibiting street vending on certain portions of Olney avenue and creating a special street vending district on North Twentieth street between West Clarkson avenue and Belfield avenue, all under certain terms and conditions.
- 170961** An Ordinance authorizing The Bagel Place Shop LLC., ("Owner") to install, own and maintain an open air sidewalk café at 404 Queen Street, Philadelphia, PA 19147 ("Property"), under certain terms and conditions.
- 170729** Resolution calling for the City Council Committee on Streets and Services to hold hearings investigating the feasibility of opening the outer lanes of the Benjamin Franklin Parkway to install more flags and increase the number of countries that are represented.
