RESOLUTION

WHEREAS, Adam Pritzker started his legal career clerking for various judges including former President Judge of the Pennsylvania Superior Court, Susan Pikes-Gantman, then working in venture and legal technology sales understanding both the legal and private industries; and

WHEREAS, Having experienced careers in the private sector and in local and state government Adam and Rachael Pritzker founded PLG as a solution for homeowners, investors, institutions, developers and non-profits to successfully interface with local government and obtain approvals and resolve various legal issues they face on a regular basis; and
