AN ORDINANCE

To amend an Ordinance approved June 8, 2006 (Bill No. 060001), relating to the Fiscal Year 2007-2012 Capital Program by decreasing project amounts in certain departments and increasing project amounts in other departments.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:
