## AN ORDINANCE

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. The following parking regulation is hereby established:

8:00 AM – 2:00 AM  
Monday - Sunday  
Except RPP #10/25

Day street, west side, Wildey street to Girard avenue.
