## Public Hearing Notice

---

The **Committee on Streets and Services** of the Council of the City of Philadelphia will hold a Public Hearing on **Tuesday, June 13, 2023, at 10:00 AM**, in a **remote manner using Microsoft® Teams**. **This remote hearing may be viewed on Xfinity Channel 64, Fios Channel 40 or <http://phlcouncil.com/watch-city-council/>**, to hear testimony on the following items:

- 230277** An Ordinance establishing parking restrictions for certain commercial vehicles in the vicinity of Erdrick street from Princeton avenue to Tyson avenue; all under certain terms and conditions.
- 230307** An Ordinance amending Section 9-208 of The Philadelphia Code, entitled “Sidewalk Cafes,” by permitting sidewalk cafes to be maintained on Frankford Avenue, both sides, from Harbison Avenue to Sheffield Avenue; Cottman Avenue, both sides, from Erdrick Street to Leon Street; Ryan Avenue, both sides, from Frankford Avenue to Leon Street; Robbins Avenue, both sides, from Frankford Avenue to Mulberry Street; Sackett Street, both sides, from Frankford Avenue to Levick Street; and the area bounded by Frankford Avenue, Levick Street, Hawthorne Street and Hellerman Street; all under certain terms and conditions.
- 230441** An Ordinance establishing parking regulations on certain streets in the area bounded by South 63rd Street, Passyunk Avenue, Essington Avenue, South 70th Street, and Lindbergh Boulevard, under certain terms and conditions.
- 230454** An Ordinance amending Chapter 11-700 of The Philadelphia Code, entitled “Right of Way Management,” by revising requirements for obtaining access to and permits for construction in the underground portion of the right-of-way and making technical changes; and amending Chapter 9-300, entitled “Communication,” by deleting provisions relating to poles and overhead wires; all under certain terms and conditions.
