Public Hearing Notice

The **Committee on Streets and Services** of the Council of the City of Philadelphia will hold a Public Hearing on **Wednesday, May 5, 2010**, at **2:00 PM**, in **Room 400, City Hall**, to hear testimony on the following items:

- 090587** An Ordinance amending Section 9-205 of The Philadelphia Code, entitled "Sidewalk Sales," by prohibiting vending on both sides of Aramingo Avenue, between Lehigh Avenue and Duncan Street, all under certain terms and conditions.
- 100213** An Ordinance amending Section 9-605 of The Philadelphia Code, entitled "Towing," by revising the provisions governing the licensing and regulation of towers, under certain terms and conditions.
- 100219** An Ordinance establishing a one-way regulation on East Duval Street, from Lowber Street to Mansfield Avenue, westbound.
- 100221** An Ordinance amending Section 2 of an Ordinance (Bill No. 051234) approved February 16, 2006, entitled "An Ordinance authorizing and directing the revision of lines and grades on a portion of City Plan No. 266 by striking from the City Plan and vacating Jefferson Street and Heston Street, each from 52nd Street to Paxon Street; by striking from the City Plan and vacating Paxon Street from Jefferson Street to Columbia Avenue; and by reserving and placing on the City Plan rights-of-way for gas main purposes, water main purposes, and drainage purposes within the beds of the streets being stricken by this Ordinance, if necessary, all under certain terms and conditions," by extending the period for compliance with the terms and conditions stated therein.
- 100226** An Ordinance amending Section 2 of an Ordinance (Bill No. 040511) approved June 21, 2004, entitled "An Ordinance authorizing the revision of lines and grades on a portion of City Plan No. 55 in the area bounded by Aramingo Avenue, Frankford Creek, and Adams Avenue, under certain terms and conditions," by extending the period for compliance with the terms and conditions stated therein.
- 100248** An Ordinance establishing a no parking anytime regulation on McMenamy Street, between Cottage Street and Jackson Street, both sides.
- 100250** An Ordinance authorizing HACE Community Development Corporation, 167 West Allegheny Avenue, Philadelphia, PA 19140, to construct, own and maintain eight trash receptacles and twelve artificial metal palm trees, on the east and west footway of 5th Street, from Lehigh Avenue to Indiana Avenue, all under certain terms and conditions.
- 100252** An Ordinance authorizing Marianos Chris Fetfatzes, owner of 738 MOC Inc. (aka Hawthornes), 1108 Fitzwater Street, Philadelphia, Pennsylvania, to construct, own
