
THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:


SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, The Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Cottman Avenue, the Montgomery County Line, the Bucks County Line, Interstate 95, Grant Avenue, and Roosevelt Boulevard from the existing zoning designations indicated on Maps "A1" through "A23," set forth below, to the zoning designations indicated on Maps "B1" through "B23," set forth below.

SECTION 2. This Ordinance shall become effective immediately.





Map A2 Existing Zoning
















Map A6 Existing Zoning

Map A7 Existing Zoning







Map A8 Existing Zoning







Map A9 Existing Zoning




Map A15 Existing Zoning




Map A16 Existing Zoning


Map A18 Existing Zoning

Map A21 Existing Zoning





Map A22 Existing Zoning









Map A23 Existing Zoning


