WHEREAS, As a proud and passionate congregant of The Sharon Baptist Church, Wims is a member of the mass choir, which has most recently performed at the Wawa Welcome to America festival, the Juneteenth Parade Festival, and The National Convention of Gospel Choirs and Choruses; and

WHEREAS, In her daily life, Wims works full-time as Security Event Staff at Lincoln Financial Field, Wells Fargo, and Citizens Bank Park; now, therefore, be it
