AN ORDINANCE

Establishing parking regulations in the vicinity of: Christian street and 11th street; Cross street and 10th street; Queen street and Front street; Moore street and 12th street; Water street and Washington avenue; Fitzgerald street and 11th street; Clarion street and Porter street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The following parking regulation is hereby established:

Queen street, both sides, Front street - Swanson street.

8:00 A.M. to Midnight
Monday - Sunday
Except RPP #7

SECTION 2. The following parking regulation is hereby established:

Cross street, north side, 10th street – 11th street.

Two-Hour Parking
7:00 A.M. to Midnight
Monday - Sunday
Except RPP #23

SECTION 3. The following parking regulation is hereby established:

Christian street, both sides, 11th street – 12th street.
