AN ORDINANCE


To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by South Street, 6th Street, Washington Avenue, and 11th Street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by South Street, 6th Street, Washington Avenue, and 11th Street from the existing zoning designations indicated on Maps "A1," "A2," "A3," "A4," "A5," "A6," "A7," "A8," "A9," "A10," "A11," "A12," "A13," "A14," "A15," "A16," "A17," and "A18" set forth below to the zoning designations indicated on Maps "B1," "B2," "B3," "B4," "B5," "B6," "B7," "B8," "B9," "B10," "B11," "B12," "B13," "B14," "B15," "B16," "B17," and "B18" set forth below.

SECTION 2. This Ordinance shall become effective immediately.




Map A3 Existing Zoning






Map A4 Existing Zoning











Map A5 Existing Zoning




Map A9 Existing Zoning










Map A10 Existing Zoning









Map A12 Existing Zoning




Map A16 Existing Zoning









Map B1 Proposed Zoning








Map B6 Proposed Zoning

Map B12 Proposed Zoning






Map B13 Proposed Zoning










Map B14 Proposed Zoning


