WHEREAS, New Holland Agriculture is a world leader in the agricultural business, and has been providing support and the sale of agricultural vehicles to farmers since 1895, with its roots emerging from New Holland, Pennsylvania, and is currently home to the largest hay tools production facility in the world; and
