AN ORDINANCE


To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Girard Avenue, 6th Street, Berks Street and 10th Street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Girard Avenue, 6th Street, Berks Street and 10th Street from the existing zoning designations indicated on Map(s) "A1," "A2," "A3," "A4," "A5," "A6," and "A7" set forth below to the zoning designations indicated on Map(s) "B1," "B2," "B3," "B4," "B5," "B6," and "B7" set forth below.

SECTION 2. This Ordinance shall become effective immediately.













Map B1 Proposed Zoning














Map B7 Proposed Zoning
