#### AN ORDINANCE


To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Allens Lane, Bryan Street, Mount Pleasant Avenue, Mower Street, Sedgwick Street (extended), Lincoln Drive, Ellet Street, and McCallum Street.

#### THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Allens Lane, Bryan Street, Mount Pleasant Avenue, Mower Street, Sedgwick Street (extended), Lincoln Drive, Ellet Street, and McCallum Street from the existing zoning designations indicated on Maps "A1", "A2", "A3" and "A4" set forth below to the zoning designations indicated on Maps "B1", "B2", "B3" and "B4" set forth below.

SECTION 2. This Ordinance shall become effective immediately.
















# **Map B2 Proposed Zoning**






# **Map B4 Existing Zoning**
