AN ORDINANCE

Establishing parking regulations in the vicinity of: Webster street and S. 18th street; Fitzwater street and S. 20th street; Christian street between S. Broad street and S. 16th street; Carpenter street and S. 24th street; Catharine street and S. 20th street; Bainbridge between 24th street and Schuylkill avenue.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The following parking regulation is hereby established:

Two Hour Parking
8:00AM – 6:30PM
Monday – Friday
Except RPP#1

Webster street, north side, 18th street to dead end east of 19th street.

Two Hour Parking
8:00AM – 12:00AM
Monday – Sunday
Except RPP#1

Fitzwater street, both sides, 20th street to 21st street.

SECTION 3. The following parking regulation is hereby established:

Two Hour Parking
7:00AM – 10:00PM
Monday – Sunday
Except RPP#1 and #22

Christian street, both sides, Broad street to 15th street.
