#### AN ORDINANCE

To amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Cobbs Creek, Baltimore Avenue, 49th Street, Grays Avenue, 58th Street, Springfield Avenue, and Cobbs Creek Parkway.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Cobbs Creek, Baltimore Avenue, 49th Street, Grays Avenue, 58th Street, Springfield Avenue, and Cobbs Creek Parkway, from the existing zoning designations indicated on Maps "A1" through "A27," set forth below, to the zoning designations indicated on Maps "B1" through "B27," set forth below.


SECTION 2. This Ordinance shall become effective immediately.


# Map A3 Existing Zoning



# Map A6 Existing Zoning








# Map A14 Existing Zoning


# Map A24 Existing Zoning


Map A25 Existing Zoning





# Map B1 Proposed Zoning










# Map B3 Proposed Zoning








# Map B7 Proposed Zoning











### Map B18 Proposed Zoning








### Map B21 Proposed Zoning





### Map B24 Proposed Zoning




Map B25 Proposed Zoning

### Map B26 Proposed Zoning




