
Amending the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by 63rd Street, Lansdowne Avenue, Felton Street, Haddington Lane, Edgewood Street, Lansdowne Avenue, 54th Street, Girard Avenue, 59th Street, and Callowhill Street.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, The Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by 63rd Street, Lansdowne Avenue, Felton Street, Haddington Lane, Edgewood Street, Lansdowne Avenue, 54th Street, Girard Avenue, 59th Street, and Callowhill Street from the existing zoning designations indicated on Maps "A1" through "A12," set forth below, to the zoning designations indicated on Maps "B1" through "B12," set forth below.

SECTION 2. This Ordinance shall become effective immediately.








Map A1 Existing Zoning











Map A2 Existing Zoning










Map A3 Existing Zoning





Map A11 Existing Zoning





















Map B1 Proposed Zoning











Map B2 Proposed Zoning






Map B5 Proposed Zoning














Map B6 Proposed Zoning












Map B7 Proposed Zoning












Map B8 Proposed Zoning











Map B9 Proposed Zoning







Map B11 Proposed Zoning











Map B12 Proposed Zoning
