RESOLUTIONS

Resolution No. 060348:Resolution proclaiming the month of May, 2006 as "NATIONAL DRUG TREATMENT COURT MONTH" in the City of Philadelphia.

WHEREAS, Drug treatment courts provide the focus and leadership for community-wide, anti-drug systems, bringing together criminal justice, treatment, education and other community partners in the fight against drug abuse and criminality; and

WHEREAS, Drug treatment court programs combine intensive judicial supervision, mandatory substance abuse treatment and drug testing, escalating sanctions and incentives and offender accountability in order to break the cycle of drug addiction, reduce recidivism and promote public safety; and

WHEREAS. The judges, prosecutors, defense attorneys, treatment law corrections professionals, enforcement and personnel, researchers educators, national and community leaders and others dedicated to the movement have had a profound impact through hard work and commitment to their communities; and

WHEREAS, The drug treatment court movement has grown nationwide from 12 courts in 1994 to over 1,700 drug treatment courts that are in operation or in the planning stages; and

WHEREAS, We support the monumental accomplishments of The Philadelphia Treatment Court, the first established in the Commonwealth of Pennsylvania in 1997. To date, the Philadelphia Treatment Court has accepted approximately 2,037 participants and credits 1,114 individuals with successfully completing the intensive program; and

WHEREAS, We recognize that The Philadelphia Treatment Court has received national distinction as a Mentor Court from the U.S. Department of Justice and the National Association of Drug Court Professionals (NADCP), one of only 30 mentor courts in the country. The court has hosted national and international dignitaries, judges and court staff; now therefore

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That we hereby proclaim the month of May, 2006 as "NATIONAL DRUG TREATMENT COURT MONTH."

FURTHER RESOLVED, That an Engrossed copy of this resolution be presented to The Philadelphia Treatment Court as evidence of the respect and admiration of this legislative body in recognizing the practitioners make participants who drug treatment courts work and contributions that drug treatment courts have made, and continue to make, in reducing drug usage and crime.

THE RESOLUTION WAS ADOPTED.

Resolution No. 060349:Resolution calling upon the Attorney General of the United States to immediately remove Donald V. Ferlise from his immigration judge position in Philadelphia due to his documented history of inappropriate treatment of those appearing before him.

WHEREAS, The Third Circuit Court wrote, "It is a hallmark of the American system of justice that anyone who appears as a litigant in an American courtroom is treated with dignity and respect. That expectation must be met regardless of the citizenship of the parties or the nature of the litigation"; and

WHEREAS, Judge Donald V. Ferlise's courtroom conduct has been condemned on multiple occasions in opinions of the United States Court of Appeals for the Third Circuit; and

WHEREAS, On April 28, 2006, federal appeals panel ruled that Judge Ferlise prejudged cases and bullied asylum-seekers by denying them a right to fair hearings; and

WHEREAS, One of these cases involved petitioner Abou Cham of The Gambia who filed an application for asylum due to his relationship with his uncle, Dawda K. Jawara, who was president of The Gambia until he was ousted by a military coup on July 22, 1994; and

WHEREAS, During the hearing, Judge Ferlise intimidated Cham into a state of confusion with "abusive" comments; and

WHEREAS, Judge Maryanne Trump Barry of 3rd U.S. Circuit Court of Appeals wrote, "Judge Ferlise continually abused an increasing distraught petitioner (Cham), rendering him unable to coherently respond to Judge Ferlise's questions.

. . The belligerence of the questioning and the tension in the courtroom fairly leap off the pages of the record"; and

WHEREAS, According to a 2000 study published by the San Jose Mercury News, Judge Ferlise is ranked among the 10 toughest asylum judges in the country. Between 1995 and 1999, Ferlise granted only 74 of 715 asylum requests; and

WHEREAS, Currently, the Attorney General is conducting a comprehensive review of the immigration courts citing concerns that certain immigration judges fail to treat persons appearing before them with appropriate respect and consideration and therefore fail to produce the quality of work expected from employees of the Department of Justice; now, therefore, be it

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That we call upon the Attorney General of the United States to immediately remove Donald V. Ferlise from his immigration judge position in Philadelphia due to his documented history of inappropriate treatment of persons appearing before him.

WHEREAS, Chapter 16-400 of The Philadelphia Code relating to vacant property, grants the City the power to convey certain classes of real property to the Redevelopment Authority of the City of Philadelphia, without consideration, to implement the public purpose set forth in that Chapter; and

WHEREAS, The Vacant Property Review Committee has recommended acceptance and disposition of the vacant property listed below; now therefore

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 4122 Poplar Street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.

SECTION 2. The Redevelopment Authority is hereby authorized to dispose of the aforementioned property for rehabilitation and/or improvements under certain terms and conditions pursuant to Chapter 16-400 of The Philadelphia Code.

SECTION 3. The City Solicitor is hereby authorized to prepare or to approve all instruments and documents and to include in such instruments and documents such terms and conditions as are necessary to effectuate the purpose of Chapter 16-400 of The Philadelphia Code.

WHEREAS, A city like Philadelphia has the ability and responsibility to protect and provide for its employees who are also city residents; now therefore

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, Calling for honor and integrity in existing collective bargaining agreements regarding housing reorganization and furthermore calling for no circumvention of the process through any reorganization effort.

Resolution No. 060353:Resolution adopting findings of fact and conclusions of law with respect to certain appeals filed in the Philadelphia Court of Common Pleas regarding Council's decision disapproving applications to sell malt and brewed beverages for consumption off- premises.

WHEREAS, Act 39 of 2005 requires that an application to the Pennsylvania Liquor Control Board for a permit to sell malt or brewed beverages for off-premises consumption in Philadelphia must be accompanied by a copy of the approval of such application by Council, which must render a decision by ordinance or resolution within forty-five days of receipt of a request for such approval; and

WHEREAS, In accordance with Sections 9-2906 and 9-2907 of the Philadelphia Code, after a hearing conducted by a hearing examiner appointed by Council,

Council, by Resolution, disapproved the application referenced in the attached findings of fact and conclusions of law; and

WHEREAS, An appeal of Council's final decision has been filed in the referenced application; and

WHEREAS, In accordance with Section 9-2909(1) of the Philadelphia Code, Council has prepared findings of fact and conclusions of law with respect to this application; and

WHEREAS, Section 9-2909(2) of the Philadelphia Code requires that Council must adopt findings of fact and conclusions of law by Resolution; now, therefore,
