

The following bills were introduced in City Council on March 1, 2007:

Bill No. 070149: An Ordinance amending Title 4 of The Philadelphia Code, entitled "The Philadelphia Building Construction and Occupancy Code", by amending Subcode "PM" (The Philadelphia Property Maintenance Code), by requiring that any advertisement or correspondence pertaining to the rental of residential property shall include the housing inspection license number for such property, providing for penalties, and making certain technical changes, all under certain terms and conditions.

Bill No. 070150: An Ordinance amending Bill No. 060378, entitled "An Ordinance approving the Fiscal Year 2007 Capital Budget providing for expenditures for the capital purposes of the Philadelphia Gas Works (including the supplying of funds in connection therewith) subject to certain constraints and conditions, and acknowledging receipt of the Forecast of Capital Budgets for Fiscal Years 2008 through 2012," by approving a revised Capital Budget for Fiscal Year 2007.

Bill No. 070151: An Ordinance authorizing the Philadelphia Authority for Industrial Development ("PAID") to file an application with the Office of the Budget, Commonwealth of Pennsylvania, under the Redevelopment Assistance Capital Program, in an aggregate amount not to exceed Three Million Dollars (\$3,000,000) to assist in the development of the Lutheran Theological Seminary Learning Center, the Allen's Lane Art Center, and the Chestnut Hill College Student and Community Center; and authorizing the City to enter into an agreement with PAID in furtherance of grant requirements; all under certain terms and conditions. 9-213 of The Philadelphia Code, entitled "Farmers' Markets," by adding a permissible location on the sidewalk of the median of the 400 block of South 2nd Street, also known as Headhouse Square, all under certain terms and conditions.

Bill No. 070153: An Ordinance amending Title 6 of The Philadelphia Code, entitled "Health Code," by adding a new section requiring that chain restaurants obtain and display certain nutrition information for food, meal and beverage items offered for sale, and by making certain technical changes, all under certain terms and conditions.

Bill No. 070154: An Ordinance amending Chapter 9-1100 of The Philadelphia Code, entitled "Fair Practices ," by providing that private entities providing taxi service shall not discriminate against individuals with disabilities by actions including, but not limited to, refusing to provide service to individuals with disabilities who can use taxi vehicles, refusing to accommodate such individuals in the use of a guide or support animal due to blindness, deafness or refusing to assist with the stowing of mobility devices, and any other assistive instrument and charging higher fares or fees for carrying individuals with disabilities and their equipment than are charged to other persons.

Bill No. 070155: An Ordinance establishing a no parking anytime regulation on the south side of Oxford Street, between 13th Street and Broad Street.

Bill No. 060899: An Ordinance authorizing and directing the revision of lines and grades on a portion of City Plan No. 359 by Placing on the City Plan St. Thomas Drive, on the northeasterly side of

Tomlinson Road, at a distance of approximately 158' northwest of Hoff Street and two 25' rights-of-way for Water Main purposes and emergency access purposes at the cul-de-sac of proposed St. Thomas Drive, the first leading in a generally southeasterly direction and the second leading in a generally northwesterly direction, under certain terms and conditions, including the dedication to the City, free and clear of all encumbrances, of the bed of St. Thomas Drive.
