Dear Mayor Nutter:

Pursuant to Section 4-604 of the Philadelphia Home Rule Charter, the City Planning Commission has reviewed Bill No. 140340 introduced by Councilmember Henon on April 24, 2014.

Bill No. 140340 will allow the City of Philadelphia to acquire two different properties located on the Delaware Riverfront from the Pennsylvania Fish and Boat Commission and one property from PAID that is currently part of the Frankford Arsenal complex. The City will then subdivide one of the Fish and Boat Commission properties and transfer a portion of that subdivided site comprising approximately 9.5 acres to PAID for industrial reuse. In exchange, the City will receive land owned by PAID located on the Delaware River waterfront at 3101 East Orthodox Street.

This will generate approximately 55 acres of high quality industrial land with frontage on Tacony Street available for industrial reuse. This is consistent with the recommendations of both the Manufacturing Task Force and the Industrial Land Use Study prepared by

PIDC in 2010.

At its meeting of May 20, 2014, the City Planning Commission recommended that Bill No.140340 be approved.

Bill No. 140341 will amend the Philadelphia Zoning map by amending the zoning classifications of certain parcels of land within an area bounded by Tacony Street, Comly Street, the Delaware River, and Bridge Street. It will rezone land from partial "CMX-3" Commercial Mixed Use and partly "SP-POA" Special Purpose - Parks and Open Space - Active use to a zoning designation of "I-2" Medium Industrial. The purpose of the change is be to facilitate the expansion of industrial land available for development and to reconfigure waterfront open space.

At its meeting of May 20, 2014, the City Planning Commission recommended that Bill No.140341 be approved.

Bill No. 140344 will allow the City of Philadelphia to transfer its interest in approximately 1.1 acres of land known as the former Kensington and Tacony Rail right-of-way to the Philadelphia Authority for Industrial Development for industrial reuse in exchange for land owned by PAID located along the Delaware River waterfront at 3101 East Orthodox Street.

This will expand the amount of City owned parkland with frontage along the Delaware River and will facilitate the development of the North Delaware Riverfront Greenway.


