Resolution No. 200482: Resolution Authorizing the Philadelphia Land Bank to dispose of 1906 N. 24th Street located in the Fifth Councilmanic District in accordance with the terms of Chapter 16-700 of The Philadelphia Code.

BILLS AND RESOLUTIONS ON FINAL PASSAGE

Resolution No. 200427: Resolution Proclaiming the week of September 14, 2020 as "Census Week" in Philadelphia.

THE RESOLUTION WAS ADOPTED.

Resolution No. 200428: Resolution Recognizing September as Suicide Awareness and Prevention Month in the City of Philadelphia, and affirming the need for suicide prevention awareness and robust mental health services.

THE RESOLUTION WAS ADOPTED.

Resolution No. 200429: Resolution Permanently recognizing the third week in August as Solar Week in the City of Philadelphia.

THE RESOLUTION WAS ADOPTED.

Resolution No. 200432: Resolution Calling on the Philadelphia Postmaster to meet with Congressman Dwight Evans and the Philadelphia Congressional delegation to discuss the alleged removal of sorting machines from Philadelphia area post offices which would cause delays in the processing of Census forms and mail-in ballots.
