**Resolution No. 220387:** Resolution Authorizing the Committees on Children and Youth and Public Health and Human Services to hold hearings concerning the imminent threat to the longstanding constitutional right to an abortion, to examine the profound and devastating local impact that the potential repeal of *Roe vs. Wade* would have on individual lives and society as a whole, and to explore what Philadelphia can do to ensure and increase access to abortion in the face of this threat.
