WHEREAS, On December 9, 1981 Philadelphia Police Officer Danny Faulkner was shot and killed by Mumia Abu-Jamal; and

WHEREAS, Mumia Abu-Jamal was convicted of first degree murder by a jury of his peers in Philadelphia; and

WHEREAS, Mumia Abu-Jamal has exhausted all legal appeals, his conviction being upheld by the Pennsylvania Commonwealth Court of Appeal, the Pennsylvania State Supreme Court, and the United States Supreme Court; and

WHEREAS, The government of St. Denis France impertinently dedicated a street to honor the convicted murderer on April 29, 2006; and

WHEREAS, The actions of the government of St. Denis is a deplorable insult and condemnation of the U. S. Judicial System, Philadelphia Police Department, District Attorney of Philadelphia, the citizenry of the City of Philadelphia, and Officer Faulkner's family; now therefore be it

*RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA*, That this Council calls upon the 108<sup>th</sup> United States Congress and the Senatorial and Congressional Representatives of the City of Philadelphia to support H. Con. RES. 407.
