provided in the lesser amount of (i) thirty thousand dollars (\$30,000) multiplied by the established predetermined ratio; or (ii) fifty percent (50%) of the median assessed value of properties granted a homestead exemption, as certified by the OPA by no later than November 15 of the year prior to the tax year.

(2.1) For tax year 2019, a homestead exclusion is hereby provided in the amount of forty thousand dollars (\$40,000).

(2.2) [Commencing in tax year 2020, and continuing thereafter,] *For tax years 2020, 2021 and 2022,* a homestead exclusion is hereby provided in the amount of forty-five thousand dollars (\$45,000).

(2.3) Commencing in tax year 2023, and continuing thereafter, a homestead exclusion is hereby provided in the amount of ninety thousand dollars (\$90,000).
