*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 1 of the Ordinance approved January 3, 1992 (Bill No. 1025-AA) is hereby amended to read as follows:

Section 1. Pursuant to subsection 9-204(8)(a) of The Philadelphia Code, City Council hereby adopts the following vendor locations [totaling three hundred (300),] as those [designations] from which vending shall be permitted:
