SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 2600 North Darien street, 2639 North Franklin street, 3124 Hutchinson street, 2049 North Lawrence street, 4148 North Marshall street, 2408 North Mutter street, 2320 North Palethorp street and 2131 North Reese street, pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the aforementioned
