## RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying fee simple title to 183 W. Atlantic Street, 600 W. Clearfield Street, 628 E. Clementine Street, 2817 N. Darien Street, 1747 Foulkrod Street, 1724 & 1726-28 N. Hope, 1723, 1725-27 & 1729 N. Howard Street, 337 E. Lehigh Avenue, 12 E. Montgomery Avenue, 531 & 535 W. Montgomery Avenue, 547 Morse Street, 1707, 2009 & 2045 North 4th Street & 3402 North 5th Street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and
