SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to Westerly Side of 139 ½ Apsley Street pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.
